Chairman Erickson called the meeting to order at 8:00 p.m.

Rasch moved, Stuhaug seconded to approve payment of the January bills in the amount of 736,653.73 for checks 65672-65747. UC

Principal Messick reported on the following: Random Student of the Day award, AIW, Elearning day.

Superintendent Clarke reported on the following: Currently, FB is under the 100 employee threshold for OSHA Mandate, Secure West Entrance project timeline, Laser Engraving machine, Voluntary Pre-K application.

Member Swenby introduced the following resolution and moved its adoption:

RESOLUTION DIRECTING THE ADMINISTRATION TO MAKE RECOMMENDATIONS FOR REDUCTIONS IN PROGRAMS AND POSITIONS AND REASONS THEREFOR.

WHEREAS, the financial condition of the school district dictates that the school board must reduce expenditures immediately, and

WHEREAS, there has been a reduction in student enrollment, and,

WHEREAS, this reduction in expenditures must include discontinuance of positions and discontinuance or curtailment of programs, and

WHEREAS, a determination must be made as to which teachers; contracts must be terminated and not renewed and which teachers may be placed on unrequested leave of absence without pay or fringe benefits in effecting discontinuance of positions,

BE IT RESOLVED, by the School Board of Independent School District No. 599, as follows:

That the School Board hereby directs the Superintendent of Schools and administration to consider the discontinuance of programs or positions to effectuate economies in the school district and reduce expenditures and, as a result of a reduction in enrollment, make recommendations to the school board for the discontinuance of programs, curtailment of programs, discontinuance of positions or curtailment of positions.

The motion for the adoption of the foregoing resolution was duly seconded by Member Strem and upon vote being taken thereon, the following voted in favor thereof: Strem, Swenby, Opdahl, Erickson, Rasch, Stuhaug, Stromstad.

whereupon said resolution was declared duly passed and adopted.

Stuhaug moved, Stromstad seconded, to authorize the continued use of the 2021 check signature plate until a new one can be obtained. UC

Opdahl moved, Swenby seconded to approve a notice of assignment for Shelley Rice- C Team Girl's BB. UC

Stromstad moved, Strem seconded to accept a STEM grant donation from Ultima Bank in the amount of \$25,000 to purchase Lego Robotics kits, Bandsaw, Macbooks, and printer. UC
